【減税額の計算式】

寄附後の所得税額 = (課税所得金額 - (寄附金額 (総所得金額の40%が上限) - 2千円)) × 所得税の税率

※ 総所得金額の算定においては、給与収入のみの「夫婦及び未婚の子2名」の世帯(配偶者収入200万円、

子は高校生1名・大学生1名)を想定し、基礎控除額・扶養控除額を課税所得金額に加算した額を総所得金額とした。
